Long Island and Saint Francis To Fight For NEC Women's Soccer Championship On Sunday

The top two seeds advanced to the championship match in the 2010 Northeast Conference Women's Soccer Tournament on Friday. In the first semifinal held at the FDU Soccer Field in Teaneck, True to form, top-seeded Long Island (8-1-1) used its vigilant backfield and consistent attack to overcome #4 Central Connecticut State (5-3-2) by a score of 1-0, marking the Blackbird's eighth conference game won by a single tally this season. The final score of the game was decided a minute and half after kickoff when Long Island's Ariana Calderon (Sacramento, CA/St. Francis) sprinted down the right sideline to send a pass inside the box to forward Katie Egan (Hanover, MA/Hanover). Acting fast, Egan chipped a cross to Toni Smith (Rainham, England/Savarro College), who found herself wide open to follow through with a header. Smith's tally was her fifth of the season. In the second semifinal, second-seeded Saint Francis (8-2) overcame a one-point deficit in the second half to tie #3 Quinnipiac (5-2-3) 2-2, sending the bout into two rounds of scoreless overtime. The Red Flash came out on top after 3-1 shootout victory to advance to Sunday's championship game. Championship match time is slated for 12:00 p.m. on Saturday on the FDU Soccer Field.

Teaneck, NJ - Second-seeded Saint Francis overcame a one-point deficit in the second half to tie #3 Quinnipiac 2-2, sending the bout into two rounds of scoreless overtime. The Red Flash came out on top after 3-1 shootout victory to advance to Sunday's championship game in the Northeast Conference Women's Soccer Tournament.

Out of the gate, both teams struggled to establish a dominate offense for the better part of the first half. Most of the play remained in the center of the field as the score was deadlocked 0-0 going into halftime. Although the Bobcats outshot the Flash 5-2 in the first half, Saint Francis was first to find its footing three minutes into the second half when **Barbara Maros de Carvalho (Sao Paulo, Brazil/Colegio Sagrado Coraco de Jesus)** collected a loose ball from teammate **Haleigh Dunyon's (Long Beach, CA/Woddrow Wilson)** corner kick. She converted into a goal by chipping it off the inside post eight yards out for her 5th goal of the season.

The Bobcats responded quickly, scoring two goals within three minutes of each other only eight minutes after the Flash tally. **Megan Mcloughlin (Rocky Hill, CT/Rocky Hill)** tapped the first one in on an assist from teammate Kristina Del Mistro (**East Williston, NY/Albertson Fury**). Next, it was Del Mistro who took one in with her low shot near the right side post to tip the scales 2-1.

With 15 minutes to go, the Saint Francis offense regained momentum as Maros de Carvalho delivered a cross to Dunyon who sent a quick pass to **Chelsea Traurig (McMurray, PA/Peters Township)** for the 2-2 tie. After regulation ended, the Red and White had outshot the Bobcats 13-12 in total and 10-6 for the second half.

During the 10-minute overtime Saint Francis kept the ball in the Bobcat end, but couldn't come up with a game-winner. However the squad settled the score during the shootout. Quinnipiac's **Furtuna Velaj (Stamford, CT/Westhill)** notched the first goal, and Red Flash's Dunyon evened it back up with her successful shot. After that the Bobcats ran into trouble by missing a shot off the post and getting a pair of rejections by Flash goalkeeper Lauren Fearer (Mount Plesant, PA/Mount Pleasant Area). Fearer's final save of the two solidified the victory as Saint Francis shooters Brianna Tata (Rochester, NY/Aquinas Institute) and **Alecia McNiff (Marietta, PA/Donegal)** both eluded Bobcat keeper **Jillian Kelley (Simsbury, CT/CFC U-20)**.

In the end Fearer recorded seven saves, while Kelley pulled in five.
